DECLARATION OF BEN STAFFORD IN SUPPORT OF SACHS PLAINTIFFS' MOTION FOR ATTORNEYS' FEES AND EXPENSES

- I, Ben Stafford, declare as follows:
- 1. I am a partner at the firm of Elias Law Group LLP and am one of the attorneys representing the Sachs Plaintiffs in this matter. I hereby submit this affidavit in support of the Sachs Plaintiffs' Motion for Attorneys' Fees, Costs, and Disbursements.
- 2. The Sachs Plaintiffs were represented in this matter by attorneys from the firms of Elias Law Group LLP (all of whom practiced at Perkins Coie LLP before September 2021) and Lockridge Grindal Nauen P.L.L.P.
- 3. A true and correct copy of Elias Law Group LLP's billing detail for its work for the Sachs Plaintiffs in this matter is attached as Exhibit A. This billing detail contains "[a] description of each item of work performed, the date upon which it was performed, the amount of time spent on each item of work, the identity of the lawyer or legal assistant

performing the work, and the hourly rate sought for the work performed" as required by Minn. Gen. R. Prac. 119.02(1).

4. Each of the attorneys and other timekeepers at Elias Law Group LLP who performed work reflected in Exhibit A charged their usual rates. However, the Sachs Plaintiffs seek fees consistent with reasonable and customary rates charged in the Minneapolis and St. Paul legal community, as reflected by the fact that the requested rates are consistent with those sought by other counsel in this matter, and as is further discussed in the affidavit of Charles N. Nauen. The rates charged and sought for each timekeeper at Elias Law Group LLP are set forth as follows:

5. Although the above-listed attorneys provided legal services to the Sachs Plaintiffs before the founding of Elias Law Group LLP in September 2021 (while they

were attorneys at the firm Perkins Coie LLP), Elias Law Group LLP seeks fees only for work performed since the firm's founding. The Sachs Plaintiffs thus deducted more than 100 billed hours from the fees they are seeking.

6. I have reviewed the original time records for this case. I affirm that the work was actually performed for the benefit of the clients and was necessary for the proper representation of the clients and that charges for any unnecessary or duplicative work have been eliminated.
