Create a core urban district or districts, and then create surrounding districts that consist of areas that are receiving the growing urban population

Create districts that maximize the ability of minority votes to elect representatives of their choice

Unite the populations of American Indian Reservations to provide better opportunities for representation in our legislature

Unify communities along major transportation corridors


Example of Precincts Other Areas of Greater Minnesota Based on Local Knowledge


