### HOW TO FILE A MOTION TO WITHDRAW A PLEA OF GUILTY<sup>1</sup> TO A PAYABLE CITATION

Use this form if:

- You received a payable citation; AND
- You were found guilty because you did not appear; OR
- You entered a guilty plea by paying all or part of the fine; OR
- You entered a guilty plea before a Hearing Officer; AND
- You want the court to reopen your case.

**NOTE:** The hearing scheduled for this motion is NOT a hearing on the citation or whether or not you are guilty of the offense(s). It is a hearing to determine whether the plea of guilty can be withdrawn on your citation.

If you have any questions regarding your legal rights and remedies, you should seek legal advice. You may find resources for getting legal advice at the Hennepin County Government Center Self-Help Center and online at www.mncourts.gov/helptopics. Click on the topic titled "Find a Lawyer" or "Legal Advice Clinics."

### **Step by Step Instructions**

- 1. Fill out the attached *Notice of Motion and Motion to Withdraw a Plea of Guilty* form.
- 2. Contact the court to receive a hearing date and time for the review. You will need it to fill out the Notice of Motion and Motion form. You can contact by phone at 612-348-6000, or in person at any Hennepin court location (see attached list of courthouses).
- 3. Write the hearing information into the Notice of Motion and Motion to Withdraw a Plea of Guilty form.
- 4. Make two copies of the completed Notice of Motion and Motion form. The original is for the court (see #7 below). One copy is for you.
- 5. The second copy must be mailed or hand-delivered to the city prosecutor for your case. (See attached list of city prosecutors.) You can do this, or you can ask someone else over the age of 18 to do this for you.
- 6. **After** the copy of the motion has been mailed/delivered, the person who mailed/delivered it must complete the attached Proof of Service.
- 7. **File** the **original** Notice of Motion and Motion (the one you filled out not a copy) and the completed Proof of Service **at least seven (7) calendar days before the hearing**. You can file these documents in one of these ways:
  - in person at any Hennepin court location (see attached list of courthouses)
  - mail to the Violations Bureau at 300 South Sixth Street, Minneapolis, MN 55487.
  - eFile using the eFile & Serve system.

Your case will not be on the calendar if you don't file on time.

8. Do not be late for your hearing. Plan on arriving early because you will have to go through weapons screening. If you get to the courtroom even a few minutes late, your motion may be denied if your case was already heard and you were not there.
