Goal 1: Family Court Enhancement Project (FCEP) is progressing slowly. FCEP goals are being finalized in order to apply for funding. Focus group meetings have occurred an da survey of the judicial officers is in progress.

Goal 2: The FCEP grant will address this.

Goal 3: A committee met regarding child protection and Family Court interactions. A county review is now underway about child safety as well as the Governor's task force.

Goal 4: The latest research was presented at the Fall Bench Retreat and at the Resource Fair CLE, both in October.

Goal 5: FVCC committees have promoted and provided training throughout 2014. Goal 6: Preliminary contacts were made about justice stakeholders' access to court

records. MGA is in the process of addressing the request and will take care of this issue in 2015.
