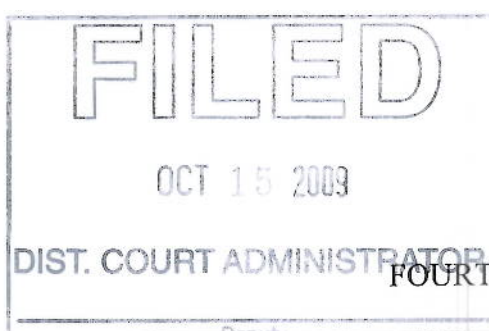

IN RE: Juvenile ITV Proceedings

**AMENDED STANDING  
ORDER**

---

WHEREAS, Under Rule 2.03, subdivision 1 of the Minnesota Rules of Juvenile Delinquency Procedure, the child has the right to be present at all hearings; and

WHEREAS, Under Rule 2.04, subdivision 1 of the Minnesota Rules of Juvenile Delinquency Procedure, the child has the right to participate in all hearings; and


WHEREAS, Rule 1.05 of the Minnesota Rules of Criminal Procedure authorizes the use of Interactive Video Teleconference (ITV) in certain proceedings.

THE FOLLOWING SHALL BE THE STANDING ORDER OF THE COURT:

1. A respondent may appear by ITV before any available juvenile court judge of the district for a six-month dispositional review hearing or for other proceedings as determined by the court.
2. The respondent's attorney need not be present at the same terminal site from which the respondent appears. However, the court shall ensure that the respondent has adequate opportunity to speak privately with counsel, including, where appropriate, suspension of the audio transmission and recording or allowing counsel to communicate with the respondent in private.
3. The respondent shall receive a copy of any documents provided to the court in preparation for the ITV proceeding.
4. Upon motion by the respondent or under other circumstances, where appropriate, the court may order that ITV not be used and that an in-person hearing occur instead.
5. ITV shall only be used when the respondent's attorney and the prosecuting attorney are physically present before the judge, unless all parties agree on the record to an alternative arrangement.
6. All ITV hearings shall be conducted in a courtroom or other room reasonably accessible to the public at the Hennepin County Juvenile Justice Center.
7. Courtroom decorum during ITV hearings must conform to the extent possible to that required during traditional court hearings.

8. During ITV hearings, all off-camera persons at any participating ITV terminal site shall be identified for the record.
9. If the hearing requires a written record, a court reporter shall be in simultaneous voice communication with all ITV terminal sites and shall make the appropriate verbatim record of the proceeding as if heard in person.
10. All ITV terminal sites shall receive notice that the creation of audio and/or video recordings of ITV proceedings is prohibited. These sites shall submit to Hennepin County Juvenile Probation a signed acknowledgment of their understanding and agreement to this prohibition before ITV proceedings may occur at the site. ITV proceedings shall not be recorded under any circumstances.
11. The juvenile court administrator shall set ITV system configuration as designated by the presiding judge of juvenile court.
