Meeting Summary

6/3/2022

Hybrid meeting - in person at Prairie Island Indian Community and virtually via Zoom

The purpose of the Tribal Court State Court Forum is to enhance tribal court and state court relationships, provide an opportunity to address issues arising from the courts' concurrent jurisdictions, collaborate on development and delivery of judicial education and training, recommend revisions to Minnesota's procedural rules of court, and work on issues that cross jurisdictional boundaries.

1. Blessing and Welcome

The meeting began with a blessing from Prairie Island Indian Community Council President, Johnny Johnson and was followed by a welcome from TCSCF Co-Chair, the Honorable Chris Anderson and the Honorable BJ Jones from Prairie Island Indian Community, along with fellow Co-Chairs, the Honorable Sally Tarnowski, the Honorable Vanya Hogen, and the Honorable Denise Reilly.

2. Review and Approve March 11, 2022 Meeting Summary

3. Overview of IV-E Reimbursement & Best Practice Tips for Judicial Officers

Beth Chapin, Paul Minehart, and Brian Mcgruder from the Department of Human Services presented an overview of IV-E reimbursement practice tips for tribal court and state court judicial officers.

4. Red Lake Nation's Approach to Child and Family Services

Judge Hogan, Judge Ringhand, and Cheri Goodwin presented on Red Lake Nation's focus on intergenerational family wellness as a framework for delivering child and family services, Gidinawemaaganinaadog: "Uplifting all of our Relatives"

5. Lunch presentation

Renee Gregory, Family Services Attorney, Prairie Island Indian Community's Family Services Program presented on enforcing tribal court civil commitment orders in state court. Forum members voices support of exploring a rule change that would give full faith and credit to tribal court civil commitment orders in state court and vice versa.

6. Collaborative Treatment Courts

Cecilia Bliss, State Treatment Court Coordinator and Lori Thompson, Court Administrator, White Earth Tribal Court, presented on the ways collaborations can form and what the data tells us about the effectiveness of treatment courts.

- Training proposals for judge conferences.
- Criminal jurisdiction intersection between law enforcement and tribal sovereignty recent MN legislation, U.S. Supreme Court's decision in U.S. vs. Cooley and other developments

that may be producing better outcomes for MN tribes and their members (recent MSBA Appellate Practice Section CLE on the topic).

• Check-in regarding TCSCF strategic priorities.
