### Warrants

If a party on a case has an active warrant, it means that a judicial officer or government official has issued a document (the warrant) authorizing law enforcement to make an arrest or carry out some other action relating to the administration of justice. The Active Warrant flag may apply to the case being viewed or another case. If you see the Active Warrant flag by a party's name in the Party Information section only, that means that party does not currently have an active warrant on the case, but they do have an active warrant on another case(s).

## Handout - Understanding MCRO Case Details and Judgment Details

### Charges (criminal cases only)

Charges are formal accusations made by a governmental authority (usually a public prosecutor or the police) asserting that somebody has committed a crime. There may be multiple charges within a case. If charges have been amended (meaning that they have been changed), the history of changes will be displayed below the current charges.

Dispositions are the outcomes of the case. Civil cases could end in a judgment such as dismissal, or settlement; and family cases can end with judgments such as support ordered, dissolutions granted, custody granted, etc.

Judgment Details provides the most recent information about monetary awards only. To see the full history (i.e., amendments of the judgment), see the Case Details (Register of Actions).

Three sections will display: Case Information, Judgment Parties, and Judgment Details. Satisfactions on the judgment will only display if satisfactions have been collected. The Satisfactions section will display all satisfactions collected. Note that total satisfactions paid will include interest paid.
